2025 Membership Renewal Form & Instructions

Include all of the following to renew your LFE membership:

1. Completed LFE Membership Renewal Form (see next page).
2. Payment: Check payable to Livermore Flying Electrons or PayPal (include a copy of your payment) or Cash (may only be delivered to an LFE club officer).
3. A copy of your AMA card or verification of "Adult" or "Youth" membership. Your AMA expiration date must be December 31, 2025, or later. Renew with AMA as needed. Renewal terms are extended from your current expiration date.

Note: Incomplete information will delay issuing your 2025 LFE ID badge.

The LFE Membership term expires on December 31 of each year. Adult Renewal dues are \$125 per calendar year. Late renewal (after January 15) is \$150. Youth (under age 19) renewal dues are \$30.

PayPal is available from our website [LFERC.com](http://www.LFERC.com). Use the pull-down list to select the payment amount then click on "Buy Now". PayPal accepts credit cards. Please include a copy of your PayPal payment with your Renewal Form.

AMA "Adult" or "Youth" membership is required by LFE. Your AMA expiration date must be December 31, 2025, or later. You can renew AMA membership online at: <https://www.modelaircraft.org/>. AMA renewal terms are extended from your existing expiration date.

The Livermore Flying Electronics Radio Control Club (LFE) flying field is located at 4455 Raymond Rd. Livermore, CA. The club is sanctioned by the Academy of Model Aeronautics (AMA). Include proof of AMA "Adult" or "Youth" membership that is valid for the entire membership year (December 31 or later).

Adult renewal dues: \$125.00 if paid on or before January 15 of the renewal year.
\$150.00 if received after January 15 of the renewal year.

Youth (under 19 years of age) renewal dues are \$30.00.

LFE Membership term expires on December 31 of each year.
